OUR CONCEPT

- participate in an educational programme that is innovative, challenging and personalised
- develop confidence and expertise in clinical practice
- increase their competency in clinical practice building on their prior training and experience
- improve their ability to communicate with other health professionals

Qualified practitioners need:

- to continually improve their ability to provide better care for their patients/clients
- ongoing education in herbal medicine at the postgraduate level
- an active programme of continuing professional development to improve their knowledge base and clinical skills in an increasingly complex health environment
- to sort out 'fact' from 'fiction' in the herbal industry
- to be aware of the current clinical issues and controversies in herbal medicine globally and locally
- to be able to integrate their practice in a conventional health care setting (if desired)
- to access practitioners and leaders in the various aspects of herbal medicine practice globally

EDUCATIONAL GOALS

During the course the student will:

- study postgraduate Units of work on specific areas of Clinical Herbal Medicine
- have access to herbal and medical expertise for their own clients/patients
- have access to an online current library with abstracts, critical literature reviews, articles, patient educational handouts and other students' work
- communicate with other health professionals in the most condensed, efficient manner for clinical discussion and research

Assessment will be through the project work associated with each Unit.

- European Herbal Practitioners Association (EHPA)

Other Health Professionals will be considered under the following guidelines:

- Doctors of Medicine – Pre-requisite Units may be required unless prior study in phytotherapy meets admission standards requiring demonstration of equivalent knowledge and skills.
- Naturopaths and Homeopaths will be accepted directly if they are professional members of the above organisations, otherwise they will be required to complete the pre-requisite course
- Midwives and nurses holding a current registration will be required to complete the pre-requisite course

The College will consider other applications on an individual basis. All students will need to have studied undergraduate courses in health sciences and herbal medicine. The postgraduate course does not include undergraduate subjects with the exception of the pre-requisite Units.

ACCREDITATION and CONTINUING EDUCATION HOURS

A certificate of study hours is available on request for each unit .

UNIT DESCRIPTIONS and COURSE OUTLINE

The Post Graduate course offers 4 Units of work. Over the years these are the units most popular. These include the first of a Power Point Series by Dr Nicky Baillie.

Some course participants may need to complete the pre-requisite course (refer Eligibility for Enrolment) or demonstrate equivalent knowledge and skills.

PREREQUISITE UNITS

Materia Medica

This Unit will include 20 detailed herb profiles with a clinical therapeutic focus, a clinical appraisal of a further 20 herbs and a therapeutic comment on a further 60-70 herbs. Students will use and expand on some of the herb profiles given, use a selection of herbal medicines provided by the College and submit evaluation reports.

Educational Objectives: At the end of this study paper the student will have a working knowledge of 40 commonly prescribed herbs and be familiar with the

main therapeutic uses of those herbs, contraindications, safety, dosing and interactions. They will also be actively involved in prescribing 10 of the herbs studied.

Understanding the Craft of Herbal Medicine and Individual Prescribing (60 hours)

Detailed information on therapeutic actions, pharmacology, formulas and dosing in herbal medicine. This Unit will cover both the traditional view of therapeutic actions of herbs and the rationale from a scientific perspective. Basic herbal pharmacology, individualising formulas, approaches to dosing and methods of dispensing are also included. Current Issues of Sustainability and Quality Herbal Medicine and Research into Plants as sentient and aware life forms are discussed.

At the end of this unit you should be able to prescribe individual formulas and dose appropriately and be more aware of the issues facing the use of Herbs as Medicine in the 21st Century.

Course General Units

Therapeutic Issues in Women's Health 1

Recent approaches to treating women with Fibroids, Endometriosis, Androgenic Hirsutism and PCOD. Recent research e.g. on insulin, essential fatty acids and growth hormone, and clinical experience adds much to our treatment of women with these conditions. This Unit gives current thinking on approaches to treatment and expected clinical outcomes.

Educational Objectives: At the end of this Unit the learner will have a better knowledge base from which they can prescribe individually for people with these conditions.

The Special Case of Pregnancy

In depth guidelines for pregnancy and childbirth. Through case studies the use of herbs safely during pregnancy and childbirth will be covered including an examination of recent claims of potential problems.

Educational Objectives: At the end of this Unit the student will have an increased knowledge base to be able to prescribe herbs during pregnancy and childbirth.

Therapeutic Issues in Women's Health 2

The Menopause Experience. A practical clinical appraisal of the use of herbal medicine to treat the symptoms of menopause including the treatment of hot flushes, use of phytoestrogens, the soy debate, 'natural' progesterone cream and the current use of HRT.

Educational Objectives: At the end of this Unit the student will be able to give informed advice to women going through menopause.

Extra

Therapeutic Issues in Men's Health

Herbal medicine can be very effective for the treatment of sexual dysfunction, benign prostatic hyperplasia, and other male reproductive health conditions.

This is an additional reading for those students enrolling in the previous 3 units.

Challenges in Clinical Practice – Working with people with Cancer.

A unit including Extensive notes, a Power point presentation and case study approach.

This unit will develop and hone both knowledge and skills in working with people with cancer. Living with cancer presents challenges at all levels – physical, mental/emotional, social and spiritual. Each person has an individual journey, but there are many common threads. These include:

- Decisions around treatment options, including combining conventional and complementary treatments.
- Choices around maintaining optimal health long term, from the myriad of advice, products and information available.
- If the cancer does progress, a journey around death and dying.

The support of an attuned, informed natural health practitioner can make a huge difference. Each of these areas will be explored during the unit:

- Combining complementary and conventional cancer treatments. These include surgery, chemotherapy, radiotherapy and hormone modulating medications. How do we work with these people safely and effectively? How can we support, and possibly even enhance, the effectiveness of these conventional treatments? How can we improve communication with oncologists and other specialists? How can we finetune our approaches to help people to get the best of both worlds?
- Developing programmes to encourage optimal health longer term for people living with cancer. Which approach for which people??
- The dying time. How do we best support people with cancer in the process of dying. Where do herbal and nutritional therapies fit in? What else can we offer?

Case studies which demonstrate some of the more difficult or challenging areas of cancer management will be presented, with opportunities to apply the principles of truly integrative cancer care.

ASSESSMENT

Assessment for the Diploma will be made on the project work associated with each Unit, the research paper, and requested work for the Clinical Discussion Group. The student will receive one of the following:

- CP - Complete pass
- PP - Partial Pass - Unit requirements are incomplete
- RU - The Unit or project work needs to be repeated

WITHDRAWAL FROM OR POSTPONEMENT OF STUDY

Once a student begins the study (Unit or Course) for which they have enrolled there will be no refund. If the student has a valid reason for withdrawing from the course they must do so IN WRITING three weeks before beginning their study. 75% of the remaining Course fees will be refunded. If the student has a valid reason for postponement of their study, they need to apply to the College IN WRITING and may be granted up to one years leave.
